1. USE OF COOKIES BY THE COMPANY

As the Data Controller, KÜTAŞ TARIM ÜRÜNLERİ DIŞ TİC. VE SAN. A.Ş. (referred to the "Company") uses cookies on its Website (the "referred to the Service"). While your access to the Service, you are regarded as you've given your consent to the use of cookies.

This Cookies Policy hereby explains:

- ✓ what cookies are,
- ✓ how The Company use cookies,

2. DEFINITION

Cookies are small pieces of text sent by your web browser by a website you visit. A cookie file is stored in your web browser and allows the Service or a third-party to recognize you and make your next visit easier and the Service more useful to you.

Cookies can be "persistent" or "session" cookies.

3. USAGE OF COOKIES

When you access the Service, The Company concurrently may install a number of cookies files in your web browser.

The Company use places:

- ✓ to enable certain functions of the Service,
- ✓ to provide analytics,
- ✓ to store your preferences,
- ✓ to enable advertisements delivery, including behavioral advertising.

Here's the table indicating types, duration and information of cookies used by The Company.

Cookie	Description	Duration	Type
_gat_gtag_UA_119694589_1	Google uses this cookie to distinguish users.	1 min	HTTP/ Analytics
_ga	Installed by Google Analytics. The cookie is used to calculate visitor, session, campaign data and keep track of site usage for the site's analytics report. The cookies store information anonymously and assign a randomly generated number to identify unique visitors.	2 years	HTTP/ Analytics
_gid	Installed by Google Analytics. The cookie is used to store information of how visitors use a website and helps in creating an analytics report of how the website is doing. The data collected including the number visitors, the source where they have come from, and the pages visited in an anonymous form.	1 day	HTTP/ Analytics

The Company may install various of cookies on the Service and uses different types of them to run the Service such as *Essential cookies or Third-party cookies*








4. COOKIE PREFERENCES

In case you wish to change your cookie preferences at any time, you may click on the 'Change my preferences' icon. You can then adjust the available sliders to 'On' or 'Off', then clicking 'Save and close'. After then, you may need to refresh your page for your settings to take effect.



Alternatively, most web browsers allow users to customize cookie preferences through the browser settings.
